VENDOR RULES

1. The space allocated is large enough for 1 table and is meant to be used for that purpose. The vendor will get approximately 3' behind the table for personal space. ALL ITEMS MUST BE ON TABLE UNLESS TABLE IS REMOVED TO USE THE FLOOR SPACE.
2. Space assignments are at the sole discretion of the Clackamas County Fairgrounds. (Space will be assigned on a first come first serve basis)
3. The application and table fees must be received by the Clackamas County Fairgrounds in order to reserve a space.
4. Chairs will be available at no charge for vendors.
5. Limited electricity is available for wall spaces only.
6. Vendors must provide their own table coverings.
7. Set-up, tear-down, and sale hours are listed above and must be followed. All Vendors must remain set-up until the end of the show.
8. Please park in the lots across the street during sale hours.
9. No solicitation is allowed outside of your specific table space.
10. Aisle ways must stay clear.
11. NO WEAPONS ARE ALLOWED TO BE SOLD. (i.e. firearms, ammunition, hunting or switchblade knives, etc.)
Kitchen & pocket knives are allowed as long as they are displayed in a safe manner and are **not sold to minors**.
12. No card or palm reading will be permitted.
13. PLEASE DO NOT HANG ANYTHING ON THE WALLS.
14. Sealed prepared food from a certified licensed kitchen may be sold. State Documentation must be posted on your booth during the Sale. Food sales directly competing with Fairgrounds Concessions may not be sold.
15. The Clackamas County Fairgrounds, Fair Board, Staff, and Clackamas County is hereby released from any/all losses. Vendors are responsible for their own security during set-up hours, sale hours, and tear down hours.
16. No refunds will be made.
17. Violation of any rule will be dealt with by Clackamas County Fair Staff.
